READ CAREFULLY. THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

I, a member or guest of Heiliger Huegel Ski Club, Inc. ("Ticket Holder" or "Releasor") understand that the sport of skiing in its various forms, including but not limited to skiing, snowboarding, and facilitating those endeavors involves risks, dangers and hazards that may cause serious personal injury or death and that injuries are a common and ordinary occurrence. Risks include, but are not limited to, changes in terrain, weather and snow surfaces, ice, moguls, bare spots, rocks, stumps, debris, fences, posts, trees, chairlift and surface lift equipment and towers, light poles, signs, buildings, roads and walkways, rails, boats. jumps and other terrain features (including their approaches and the angle of their take-off ramps and landing areas) both in and out of any terrain park, padded and non-padded barriers and obstacles, snowmaking, snow grooming, snowmobile operations, and collisions with other persons and other natural and man-made hazards. I acknowledge that the risks in the sport can be greatly reduced by taking lessons, abiding by the Skier Responsibility Code (known as Your Responsibility Code), and using common sense. If I am a member of Heiliger Huegel Ski Club, Inc., I confirm that I executed the Club's standard release if and when I joined the Club and that this Release supplements that earlier release and that both remain in full force and effect.

In consideration of the purchase of a lift ticket or membership in Heiliger Huegel Ski Club, Inc. and use of its facilities, I RELEASE AND FULLY DISCHARGE Heiliger Huegel Ski Club, Inc., its members, officers, directors, and employees (collectively "RELEASEES") from any liability resulting from any personal injury to myself, including death, or damage to my property which is caused by the BREACH OF ANY EXPRESS OR IMPLIED WARRANTY or the NEGLIGENT ACT OR OMISSION OF ANY RELEASEE in the design, location, construction, inspection, maintenance and repair of the conditions on or about the premises or ski area or the operations of the ski area, including without limitation:

- the design, location, construction, inspection, maintenance and repair of trails, ski runs and slopes;
- the design, location, construction, inspection, maintenance and repair of terrain features, including rails, boxes, table top and other forms of jumps, including their approaches and the angle of the take-off ramps and landing areas;
- grooming, snowmaking, and snowmobile operations, and the operation of chair and surface lifts and chair and surface lift loading unloading operations;
- padding or non-padding of natural and manmade obstacles and hazards;
- posting or failure to post warnings and signs, and the construction or failure to construct fences or other barriers, including the selection of the construction materials; and
- classification and labeling of trails and ski runs.

I accept full responsibility for any injuries or damages which may result from the participation in the sport of skiing, and thereby **HOLD HARMLESS** the RELEASEES for any injury sustained by me, including death, while participating in the sport. I agree not to bring any action or suit against the RELEASEES for any injury or damage.

In accordance with Wisconsin law, nothing in this Release should be considered as releasing, discharging or waiving any claims I may have for reckless or intentional acts on the part of any RELEASEE. THE UNDERSIGNED agrees that ANY CLAIM for injury and/or death against any RELEASEE shall be governed by the laws of the State of Wisconsin.

I HAVE CAREFULLY READ THIS RELEASE AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT BY SIGNING THIS RELEASE, I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE HEILIGER HEUGEL SKI CLUB, INC., ITS MEMBERS, OFFICERS, DIRECTORS, AND EMPLOYEES FOR CERTAIN CLAIMS. I UNDERSTAND I AM ABLE TO EXERCISE THE OPTION TO DECLINE TO EXECUTE THIS RELEASE.
