SPONSOR INFORMATION

The following guidelines and checklist are provided to assist you in properly preparing and submitting your proposed member's application form. It is important that both sponsors review these guidelines because an application which is incomplete will not be considered by the Membership Committee. Responsibility for completeness remains solely with the sponsor. If you have any questions or problems, please contact either the Hill Manager or one of the Club Directors for assistance.

GENERAL INFORMATION:

Only club members in good standing, who are NOT Junior members, Corresponding members, or Club Directors may act as sponsors for club membership. ONE MEMBERSHIP MAY SPONSOR OR Co-SPONSOR ONLY ONE APPLICATION IN ANY GIVEN SEASON.

All Membership Application Packages must include the following:

1. The membership application form, properly completed and signed by the applicant, and both sponsors.
2. A dated, signed and sealed letter of recommendation from each of the sponsors.
3. A postmark indicating a mailing date of not earlier than May 1st, nor later than July 31st (completed applications received after July 31st, but prior to the following May 31st, may be considered for membership by the Board if memberships are available and if the Board determines that such memberships are in the best interest of the club).

PROCEDURE:

- [] Deliver to the proposed member, the enclosed membership application form and applicant instruction sheet.
- [] Review with the applicant, the responsibilities associated with club membership.
- [] Advise the applicant to return the completed application to the sponsor, including both sponsor's signatures.
- [] Review the application for completeness.
- [] Enclose the application and all related documents in one submittal envelope. Please mail the envelope to:

The postmark on the submittal envelope will be considered the date of application.

APPLICANT'S CERTIFICATION

1. If elected to membership, applicant agrees to be bound by the Articles of Incorporation and by all By-Laws, rules and regulations adopted by the Club.
2. By signing this application for membership, and as a specific condition of election for membership, applicant (hereinafter called "member") expressly agrees (and in the event the application is for a Family Membership, the applicant so agrees on behalf of all of the individuals covered by such Family Membership under the By-Laws) that the Heiliger Huegel Ski Club (the "Club") shall not be liable to such member (which herein is always deemed to include all individuals who are so covered by a Family Membership) for any and all claims, actions, causes of action, damages, costs, expenses or compensation which may hereafter be incurred by such member or his or her guests on account of, or in any way growing out of, any and all known or unknown or seen or unforeseen bodily and personal injury to, or death of, any such member (including all individuals who are so covered by a Family Membership) or any guests of such member (who avail themselves of the privileges provided by the Club) and resulting from any accident, casualty or event involving such member or guest and arising out of skiing within, or otherwise frequenting, the Club's ski area, and further, each member is deemed to have agreed to, and agrees, to hold the Club harmless of and from any such claims, actions, causes of action, damages, costs, expenses or compensation which may be made, or be incurred, by any guest of such member. In this connection, each such member (including all individuals who are covered by a Family Membership) as a condition of election to membership assumes and understands that skiing is a hazardous sport, that bare spots, variations in snow, ice and terrain along with bumps, moguls, stumps, forest growth and debris and rocks and many other hazards or obstacles exist within the corporation's ski area. In using the corporation's facilities and skiing at the area, such dangers are recognized and accepted, whether they are marked or unmarked. Such members (including their guests) realize that falls and collisions do occur and injuries may result and therefore, assume the burdens of skiing under control at all times. Moreover, applicant expressly agrees that all of applicant's guests shall have consented and agreed to the foregoing provisions as regards themselves.
3. I recognize that Heiliger Huegel Ski Club is not a 'Club' in the traditional sense, but more closely resembles a co-operative in which a large part of the organization, operations, maintenance, and capital improvements are performed by the members. I understand that these tasks are performed voluntarily in addition to the once or twice per season standard chair lift operations duty. IF ELECTED TO MEMBERSHIP, I WILL UNDERTAKE TO ASSUME MY SHARE OF THE TOTAL OF THE WORK NECESSARY TO SUCCESSFULLY CONDUCT THE ACTIVITIES OF THE CLUB.
4. I understand that if this application is neither accepted nor rejected during the current skiing season, it will not carry over to the next season to receive consideration therein.
5. If this application is for a Family Membership, this certification applies to each person constituting a part thereof.
6. I agree to pay the Initiation Fee, dues and assessments according to the schedule of fees, dues and assessments as in effect from time to time.
